REVOLUTIONARY COUNCIL DECREE NO. 1 OF 1978

**A DECREE TO AMEND THE PEOPLE'S COURTS DECREE,
1969**

IN EXERCISE of the powers conferred by the Legislative Powers Law, 1964, the Chairman for the Revolutionary Council by and with the advice and consent of the Revolutionary Council hereby makes the following Decree:-

1. This Decree may be cited as the People's Courts (Amendment) Decree, 1978 and shall be read as one with the People's Courts Decree, 1969, hereinafter referred to as the principal Decree.

Short title
Decree No. 11
of 1969.

2. Section 2 of the principal Decree is hereby repealed and replaced by the following new sections to be numbered 2 and 2A:-

Section 2 repealed
and replaced.

"People's Area Courts."
"2.(1) There is hereby established in every designated area to be published in the Gazette a People's Area court which subject to the provisions of any law for the time being in force shall exercise jurisdiction within the limits of the area in which it is established.

(2) The designation of the People's Area Court shall be the People's Area Court of the area in which it is established.

(3) The People's Area Courts shall be effective from a date to be appointed by the Chairman of the Revolutionary Council.

"People's District Courts."
2A.(1) There is hereby established in every District a People's District Court which subject to the provisions of any law for the time being in force shall exercise jurisdiction within the District in which it is established.

(2) The designation of the People's District Court shall be the People's District Court of the District in which it is established.

(3) With effect from a date to be appointed by the Chairman of the Revolutionary Council the People's Courts established and listed in Schedule 1 of the principal Decree shall duly constitute the People's District Courts for the districts in which they are established.

"Provided that the Chairman of the Revolutionary Council may by order published in the Gazette vary Schedule I by adding or reducing the number of courts."

Addition of new proviso.

3.(1) Section 3 (1) of the principal Decree is hereby amended by adding the following proviso at the end thereof:-

"Provided that in the case of People's Area Courts, the Chairman and the members of the Court shall be appointed by the Chairman of the Revolutionary Council upon the recommendation of the Revolutionary Committees of the areas concerned through the Revolutionary Council's Committee for Defence and Security."

Addition of new Sub-section (5). (2) Section 3 of the principal Decree is hereby amended by adding a new subsection immediately after subsection (4) of section 3 to be numbered subsection (5):-

"(5) In the absence of the Chairman one of the members shall preside over the proceedings of the Court."

Section 8 repealed and replaced.

4. Section 8 of the principal Decree is hereby repealed and replaced by the following new sections to be numbered 8, 8A, 8B and 8C:-

"Jurisdiction and powers of People's Area Courts". "8.(1) A People's Area Court shall have and exercise jurisdiction."

(2) In all criminal proceedings in which the sentence that may be imposed is one which does not exceed six months at an Educational Centre or a fine or order of compensation not exceeding six hundred shillings.

(3) In all proceedings of a civil nature in which the value of the subject matter of the suit does not exceed two thousand shillings.

(4) The jurisdiction of the People's Area Court in criminal matters shall be limited to the offences set out in the Second Schedule to this Decree.

(5) All criminal cases before the People's Area Courts shall be heard and disposed within twenty-one days from the date of their being filed.

Appeal from People's Area Court. (6) (a) Any person aggrieved by an order or decision of the People's Area Court may appeal therefrom to the People's District Court of the district in which the People's Area Court is established.

(b) Every appeal to the People's District Court shall be by way of petition within thirty days after the date of the decision or order against which the appeal is lodged:

Provided:-

The People's District Court may at its discretion extend the time for filing an appeal and provided further that the People's District Court may at its discretion permit an appellant to state the grounds of his appeal orally and shall record the same and hear the appeal accordingly.

(c) No appeal shall be allowed:-

(i) in any case in which a People's Area Court has passed a sentence not exceeding one hundred shillings or made an order of compensation for an amount not exceeding one hundred shillings;

(ii) in any case in which an accused person has been convicted on his own plea of guilty except against sentence only.

Jurisdiction and power of People's District Court. 8A. (1) A People's District Court shall have and exercise jurisdiction:-

(a) in all criminal cases arising within the limits of the area of its jurisdiction except for the offences listed in the Third

Schedule to the principal Decree which shall be exclusively heard by the High Court.

(b) in all proceedings of a civil nature in which the value of the subject matter of the suit does not exceed ten thousand shillings;

Power of People's District Court on Appeal.

(c) in the exercise of its appellate jurisdiction the People's District Court shall have power to hear and determine appeals brought from the People's Area Courts.

Appeals from People's District Court.

(2)(a) In both criminal and civil proceedings any person aggrieved by the decision of the People's District Court in its original or appellate jurisdiction may within thirty day after the date of the decision or appeal therefrom to the High Court:

Provided that:-

the High Court may at its own discretion extend the time for filing an appeal after the expiry of the period prescribed.

Power of High Court on appeal.

(b) Every appeal to the High Court shall be by way of petition to be filed in the People's District Court from the decision or order of which the appeal is brought:

Provided that:-

The High Court may permit an appellant to state the grounds of his appeal orally and shall record the same and hear the appeal.

(c) Upon receipt of petition of appeal or stated grounds of appeal the People's District Court shall without delay despatch the same together with any other available record of the case to the High Court.

(d) In the exercise of its appellate jurisdiction under this Decree, the High Court shall have power to hear and determine appeals, confirm or substitute conviction or sentence, quash or enhance the same with a view to meet the ends of justice in terms of the law and evidence.

Supervisory powers of the High Court. 8B. The High Court shall exercise general powers of supervision and revision over the People's Area and District Courts in the exercise of their jurisdiction under this Decree and may at any time:-

- (a) call for and inspect the record of any proceedings under this Decree from the People's Area or the People's District Court so as to satisfy it self as to its correctness and propriety of the decision;
- (b) direct any People's District Court to call for inspection or revision of any proceeding of a case heard by the People's Area Court established in its district.

Right of appeal to the Supreme Council. 8C. Any person aggrieved by the decision of the High Court in its original or appellate jurisdiction may within thirty days after the date of the decision or order against which the appeal is lodged, appeal to the Supreme Council."

5. The principal Decree is hereby amended by:-

(a) re-designating the Schedule to the principal Decree as "the First Schedule" - People's District Courts;

Amendment of the principal Decree.

(b) inserting immediately after the Schedule:-

- (i) Second Schedule - Jurisdiction of People's Area Court offences;
- (ii) Third Schedule - offences exclusively for High Court jurisdiction.

6. Subject to the provisions to this Decree or any other law appeal shall lie to the High Court from judgement decrees or orders of Kadhi's Courts in similar manner as those from People's District or Area Courts.

REVOLUTIONARY COUNCIL DECREE NO. 2 OF 1978

**A DECREE TO AMEND THE CRIMINAL PROCEDURE
DECREE,**

IN EXERCISE of the powers conferred by the Legislative Powers Law, 1964, the Chairman of the Revolutionary Council, Zanzibar, by and with the advice and consent of the Revolutionary Council hereby makes the following Decree:-

Short title. 1. This Decree may be cited as the Criminal Procedure (Amendment) Decree, 1978 and shall be read as one with the Criminal Procedure Decree, hereinafter referred to as the principal Decree.

Cap. 14 and Decree No. 3 of 1972.

2. The principal Decree is hereby amended by adding the following new section immediately after section 200 to be numbered 200A and 200B.

Addition of new sections 200A, 220B.

“Trials to be with assessors.” 200A.(1) All trials before the High Court shall be with the aid of assessors the number of whom shall be three or more as the court thinks fit.

(2) The High Court Registrar shall prepare a list of suitable persons from various Revolutionary Committees of the Districts or Areas liable to serve as assessors.

Summoning of assessors. (3) The High court Registrar shall summon in writing an assessor requiring his attendance as an assessor at a time and place to be specified.

Selection of assessors. 200B. (1) When a trial is to be held with the aid of assessors, the court shall select three from the list of those summoned to serve as assessors at the sessions.

Absence of assessors. (2) If in the course of a trial with aid of assessors, at any time before the finding, any assessor is from any sufficient cause unable to attend throughout the trial, or absents himself, and it is not practicable immediately to enforce his attendance, the trial shall proceed with the aid of the other assessors.

(3) If two or more of the assessors are unable to attend to the trial or absent themselves, the proceedings shall be stayed and a new trial shall be held with the aid of fresh assessors.

(4) If the trial is adjourned, the assessors shall be required to attend at the adjourned sitting and at any subsequent sitting until the conclusion of the trial."

3. Section 207, 208 and 209 of the principal Decree are hereby repealed and replaced by the following new sections to be numbered 207, 208 and 209 respectively:-

New sections 27,
208 and 209.

Opinions of assessors and judgment. 207.(1) When the case on both sides is closed, the Chief Justice may sum up the evidence for the prosecution and the accused person and shall then require each of the assessors to state his opinion.

(2) The Chief Justice shall then give judgment but in doing so shall not be bound to conform with the opinions of the assessors.

(3) Notwithstanding the provisions under this section or any other law, the assessors or any of them may retire to consider their opinions if they so wish or to consult with one another during any such retirement or at any time during the trial.

Judgement by Chief Justice. 208.(1) If the accused person is convicted, the Chief Justice shall pass sentence according to law.

(2) If the accused person is "found not guilty", the Chief Justice shall discharge such an accused person from that charge and order his release forthwith.

Evidence arriving at proper sentence. 209. The Chief Justice may, before passing sentence receive such evidence as it may be considered necessary for an appropriate sentence to be passed."

DECREE**

IN EXERCISE of the powers conferred by the Legislative Powers Law, 1964, the Chairman of the Revolutionary Council, Zanzibar, by and with the advice and consent of the Revolutionary Council hereby makes the following Decree:-

| Short title. | 1. This Decree may be cited as the Supreme Council (Amendment) Decree, 1978 and shall be read as one with the Supreme Council Decree, hereinafter referred to as the principal Decree. |
| Decree No. 4 of 1970. | 2. Section 2 of the Principal Decree is hereby amended by substituting for subsection (3) thereof the following new subsection to be numbered (3):- |
| Amendment of section 2. | “(3) The Supreme Council shall regularly meet whenever there is business to be attended on notification by its Chairman.” |
| Amendment of section 3. | 3.(1) Subsection (1) of section 3 of principal Decree hereby amended by repealing the proviso thereof and replacing it by the following new proviso:-

“Provided that in regard to matters referred to it by the Chairman of the Revolutionary Council under subsection (1) (b) no determination or decision of the Supreme Council shall take effect until such determination or decision as the case may be is endorsed by the Chairman of the Revolutionary Council.”

(2) Subsection (2) of section 3 of the principal Decree is repealed and replaced by the following new subsection to be numbered (2):- |

“(2) Any determination or decision of the Supreme Council on matters brought to it under subsection (1)(a) of this section shall be final and on matters brought to it under subsection (1) (b) of this section the Supreme Council’s determination or decision shall be final after its endorsement by the Chairman of the Revolutionary Council.”

4. The principal Decree is hereby amended by adding the following new section immediately after section 3 to be numbered 4:-

“Prerogative of Mercy.” 4. After the determination by the Supreme Council, in appropriate cases, the Chairman of the Revolutionary Council may exercise his Prerogative of Mercy granting to any convicted offender a pardon subject to lawful conditions.

REVOLUTIONARY COUNCIL DECREE NO. 4 OF 1978

**A DECREE TO RE-ENACT AND REPLACE THE PUBLIC
ENTERPRISES DECREE OF 1966**

IN EXERCISE of the powers conferred by the Legislative Powers Law, 1964, the Chairman of the Revolutionary Council by and with the advice and consent of the Revolutionary Council hereby makes the following Decree:-

Short title 1. This Decree may be cited as the Public Enterprises Decree, 1978.

Interpretation. 2. In this Decree unless the context otherwise requires:-

“**Board**” means a Board of Directors established under section 5;

“**Chairman**” means the Chairman of the Revolutionary Council;

“**Government**” means the Revolutionary Government of Zanzibar;

“**Minister**” means the Minister stated in the Order made under section 4(1) to be responsible for the Public Enterprise.

Establishment of Public Enterprise. 3. (1) The Chairman may by order published in the Gazettee establish any Public Enterprise for the purpose of carrying on any business, trade or undertaking for the purpose of providing any service and for such other functions as may be specified in such order.

(2) Every Public Enterprise established by an order made under this section, with effect from the date of such order, shall:-

(a) have perpetual succession and a common seal;

(b) in its corporate name be capable of suing and being sued;

(c) subject to the provisions of this Decree and of any order made in that behalf be capable of purchasing and otherwise acquiring, and of alienating, any property, movable or immovable;

(d) subject to the provisions of this Decree and of any order made in that behalf enter into contracts.

4. (1) Every order made under section 3 establishing a Public Enterprise shall provide for the following:- Order

(a) the name and composition of the Public Enterprise;

(b) the Minister responsible for the Public Enterprise;

(c) the objects of the Public Enterprise;

(d) the Head Office of the Public Enterprise.

(2) In such order the Chairman may exempt any Public Enterprise from complying with the requirements of any either temporarily or permanently.

5. (1) There shall be established a Board of Directors for every Public Enterprise incorporated under the provisions of this Decree. Board of Directors.

(2) Subject to the provisions of this Decree the Board of Directors shall be responsible for the policy, control and management of the Public Enterprises. Management of Public Enterprise.

(3) The Board shall consist of:- Composition.

(a) a chairman, who shall be appointed by the Chairman;

(b) such other members, being not less than five nor more than ten, as the Minister may appoint.

“Provided that in Public Enterprises for which Executive Chairmen have been appointed as such, shall also be the Chairmen of the Boards.

(4) The Chairman and other members of the Board shall be appointed from amongst persons who have had experience of, or shown capacity in or otherwise knowledgeable of the activities to be undertaken by the Public Enterprise.

(5) The Board may elect one of their members to act as deputy chairman.

(6) The Minister may appoint a competent person from among the employees of a Public Enterprise to be the Secretary to the Board. The Secretary shall keep minutes and records of the Board's meetings.

- (7) The Chairman may make regulations with respect to:-
- (a) the appointment of and the tenure and vacation of office by the members of a Board;
 - (b) the quorum, proceedings and meetings of a Board and determinations of a Board;
 - (c) the execution of instruments, and the mode of entering into contracts by or on behalf of the Public Enterprise, and the proof of documents purporting to be executed, issued or signed by the Public Enterprise, or a Director, Officer, or servant of the Public Enterprise.

(8) Subject to any regulations made under subsection (6) of this section the Board shall have power to regulate their own procedure.

(9) A Board shall meet at least every three months.

Proceedings of Board not to be invalid by reason of irregularity.

6. No act or proceeding of the Board shall be invalid by reason only of the number of members not being complete at the time of such act or proceeding or of any defect in the appointment of any member or the fact that any member was at the time disqualified, or disentitled to act as such.

General Manager and other officers.

7.(1) For every Public Enterprise the Chairman may appoint a General Manager or Executive Secretary on such terms and conditions as may be determined who shall be the Chief Administrative Officer of the Public Enterprise concerned responsible to the Board of Directors:-

- (a) for the proper day-to-day administration of the Enterprise in accordance with the policy laid down by the Board;
- (b) for the enforcement of staff and financial regulations that may be laid down by the Board;
- (c) for reporting on the activities of the Public Enterprise at every meeting of the Board;

(2) In like manner a Deputy to the General manager or Executive Secretary may be appointed by the Chairman to whom the General Manager may delegate some of his powers.

(3) The Board may employ such officers and other employees of the Public Enterprise as in the opinion of the Board are necessary for the efficient performance of the functions of the Public Enterprise under this Decree.

(4) The Board may delegate to the General Manager their function of appointing officers and employees either generally or in relation to any category of officers and employees.

8.(1) The Minister may give to the Board directions of a general character as to the exercise and performance by the Board of their functions in relation to matters appearing to the Minister to affect the national interest and the Board shall give effect to any such directions.

Powers of Minister in relation to Board.

(2) The Board shall afford to the Minister facilities for obtaining information with respect to the property and activities of the Public Enterprise and shall furnish him with returns, accounts and other information with respect thereto and afford to him facilities for the verification of information furnished, in such manner and at such times as the Minister may require.

9.(1) Every order made under section 3 shall indicate the nominal capital of a Public Enterprise.

Authorised capital.

(2) The authorised capital of a Public Enterprise may be increased or varied by a resolution of the Board as on the direction of the Minister.

10. The funds and resources of a Public Enterprise shall consist of:-

Funds and resources of a Public Enterprise.

- (a) the paid-up capital;
- (b) such sums as may be provided by the Government by way of loan or equity for the purposes of the Public Enterprise;
- (c) any sums borrowed by the Public Enterprise in accordance with the provisions of this Decree;
- (d) any sums which may in any manner become payable to the Public Enterprise as the result of the performance by the Public Enterprise of its functions.

Power to borrow. 11.(1) With the prior approval of the Minister, the Board of Directors of every Public Enterprise established under this Decree may, from time to time, borrow moneys for the purposes of the Public Enterprise by way of loan or overdraft, and upon such security and such terms and conditions relating to the repayment of the principal and the payment of the interest as, subject to the directions by the Minister, the Board may deem fit.

(2) The Government may guarantee in such manner and on such condition as it may think fit for the repayment of the principal and the payment of interest and other charges on any borrowings of a Public Enterprise under and in accordance with an order made under subsection (1), and any sums required for the fulfilling of any such guarantee shall be charged on and issued out of the Consolidated Fund.

(3) The Government may, with the approval of the Revolutionary Council, raise moneys, either within or outside the United Republic of Tanzania, Zanzibar, specifically for the purposes of a Public Enterprise and all moneys so raised shall be charged and issued out of the Consolidated Fund, and when paid to the Public Enterprise shall form part of its funds.

Government Revenue. 12.(1) Every Public Enterprise shall remit to the Ministry of Finance such proportion of its net profits and at such intervals as the Minister for Finance in conjunction with the Board may determine.

(2) All sums received by the Government from a Public Enterprise as provided in this section shall be paid into the Consolidated Fund.

Accounts and Audit. 13.(1) The Board shall cause to be provided and kept proper books of account and records with respect:-

(a) the receipt and expenditure of moneys by, and other financial transactions of, the Public Enterprise;

(b) the assets and liabilities of the Public Enterprise, and shall cause to be made out for every financial year a balance sheet showing details of the income and expenditure of the Public Enterprise and all its assets and liabilities.

(2) Within six months of the close of a financial year the accounts including the balance sheet of the Public Enterprise in respect of that financial year shall be audited by auditors of high repute who shall be appointed by the Minister for the time being responsible for finance.

14. The General Manager or Executive Secretary shall at the end of each financial year, prepare a report on the activities of a Public Enterprise during the financial year and submit such report to the Minister.

Public Enterprise report.

15. The Minister shall as soon as may be practicable and not later than twelve months after the close of a financial year, submit to the Revolutionary Council.

Minister to report Revolutionary Council.

- (a) a copy of audited statement of accounts of the Public Enterprise;
- (b) a copy of the auditor's report, if any; and
- (c) a copy of the General Manager's report.

16. (1) The Chairman may by order dissolve any Public Enterprise, amalgamate any two or more Public Enterprises or re-construct a Public Enterprise into two or more Public Enterprises.

Power to reorganise Public Enterprise.

(2) Such order shall set out the terms of dissolution, amalgamation or re-construction as the case may be.

17. (1) The Chairman shall appoint a Registrar of Public Enterprises to perform the duties imposed by this Decree.

Register of Public Enterprises.

(2) The Registrar shall maintain a register containing the following particulars:-

- (a) the name of the Public Enterprise;
- (b) the objects of the Public Enterprise;
- (c) the Head Office of the Public Enterprise;
- (d) the names of the General Manager and his Deputy and the principal accountant;
- (e) the nominal capital of the Public Enterprise;
- (f) the Ministry responsible for the Public Enterprise;
- (g) the chairman and the members of the Board.

(3) The Registrar shall devise a form for obtaining the information required in subsection (2) of this section.

(4) It shall be the duty of each General Manager or Executive Secretary to have the form, mentioned in subsection (3) of this section, filled and filed with the Registrar at the time of incorporation of a Public Enterprise and at any other time there is an alteration in any of the particulars required in subsection (2) of this section.

(5) A copy of the minutes of every Board's meeting and the report required under section 14 of this Decree shall be submitted to the Registrar.

(6) In the case of Public Enterprises whose Boards do not either hold meetings regularly or furnish copies of the minutes or reports as required under this Decree, the Registrar shall first draw the attention of the chairman of the Board of the Public Enterprises concerned. Thereafter, if no steps are taken in compliance with the law then the Registrar shall notify the Minister for necessary appropriate action against either the Board or Management of the Public Enterprise concerned.

Exemption from stamp duty and other charges.

18. Notwithstanding the provisions of any law providing for the registration of documents or the payment of stamp duties, for certificates, instruments or other documents issued by or in favour of any Public Enterprise acting within the powers conferred upon it by this Decree or otherwise shall be subject to exemption in appropriate cases by the relevant authorities in regard to stamp duty, registration fee or any charge of a similar nature; or the payment of search or inspection fee.

Delegation of powers.

19. The Chairman may, by an order in the Gazette, delegates all or any of his powers under this Decree, other than his power under section 3 to establish a Public Enterprise, to a Minister or a committee charged with the smooth running of Public Enterprises and may empower the Minister or such committee to make regulations concerning any matter in relation to any or all Public Enterprises.

Transitional provision.

20. Save for the necessary modifications that may from time to time, be effected the Public Enterprises established under the Public Enterprises Decree, No. 1 of 1966 shall unless otherwise expressly stated in an order published in the Gazette remain as duly constituted under this Decree.

Repeal of Decree No. 1 of 1966.

21. The Public Enterprises Decree, 1966 is hereby repealed.

REVOLUTIONARY COUNCIL DECREE NO. 5 of 1978

**A DECREE TO MAKE PROVISION FOR LOANS RAISED
AND GUARANTEES GIVEN BY THE GOVERNMENT AND
ACCEPTANCE OF GRANTS MADE TO THE GOVERNMENT AND
FOR MATTERS CONNECTED THEREWITH AND INCIDENTAL
THERETO**

IN EXERCISE of the powers conferred by the Legislative Powers Law, 1964, the Chairman of the Revolutionary Council hereby makes the following Decree:-

1. This Decree may be cited as the Government Loans, Stocks, Grants Guarantees and Decree, 1978. Short title.

2. In this Decree, unless the context otherwise requires:- Interpretation.

“Government” means the Revolutionary Government of Zanzibar;

“Minister” means the Minister for the time being responsible for Finance;

“Local loan” means a loan raised by the Government from within Zanzibar or Tanzania Mainland;

“Foreign loan” means a loan raised by the Government from outside Tanzania;

“general revenue” means the General revenue and other funds of the Government;

“bill” means a Treasury bill issued in terms of the provisions of this Decree;

“stock” means stock issued in terms of the provisions of this Decree;

“bond” means a bond issued under the provisions of this Decree;

“Security” means a document issued under the authority of the Minister as evidence of a local loan raised in accordance with the provisions of this Decree;

“public enterprise” means a body corporate established under the Public Enterprises Decree, 1978 or any other laws of Zanzibar in which the majority of the issued share capital are wholly or partly owned by the Government.

Authority to raise local loans.

3. Subject to the provisions of this Decree the Minister or any other authorised officer may, in any financial year for and on behalf of the Government, from time to time by the issue of Treasury bills, bonds stocks or such other method as the Minister may deem expedient raise loans from within Zanzibar or Tanzania Mainland of such sums as in the opinion of the Minister are necessary to defray expenditure which may lawfully be defrayed from general revenue:

Provided that in no financial year the aggregate of the payments required to be made in respect of all outstanding loans raised under this section in that year shall exceed two hundred million Tanzania shillings or such greater sum as the Revolutionary Council may in relation to any financial year by resolution decide.

Authority to raise foreign loans.

4.(1) Subject to the provisions of this Decree the Minister or any other authorised officer may, in any financial year for and on behalf of the Government from time to time raise from outside Zanzibar or Tanzania Mainland upon such terms and conditions as to interest, repayment or otherwise as may be agreed, loans of such sums as in the opinion of the Minister are necessary to defray expenditure which may lawfully be defrayed from general revenue.

Provided that in no financial year the aggregate of the payments required to be made in respect of all outstanding loans raised under this section in that year shall exceed one hundred and fifty million Tanzania shillings or the equivalent thereof in the currency in which the loan is raised or such greater sum as the Revolutionary Council may in relation to any financial year by resolution decide calculated at the rate of exchange in force at the time of the raising of the loan.

(2) The Revolutionary Council may by resolution amend or vary the ceilings of any loan raised under this section or section 3.

Conditions on bills.

5. Where a local loan is raised by the issue of bills, stocks or bonds, the following provisions shall apply:-

(a) bills and bonds shall be issued upon the best and most favourable terms or conditions that can in the opinion of the Minister be obtained:

Provided that no bill issued may provide for maturity at a date later than one year after the date of issue;

(b) stock shall be issued as registered stock upon the best and most favourable terms and conditions that can, in the opinion of the Minister be obtained and shall be transferable by written instrument of transfer;

- (c) every stock certificate lawfully issued shall be prima facie evidence of the title of the person named therein to the stock therein specified;
- (d) stock shall be redeemable at per on a date to be named when issuing it, such date not being later than thirty five years from date of issue;

Provided that the Minister may reserve the option to redeem the stock in whole or in part, by drawing or otherwise, at any time prior to such a date, on such conditions as may be declared at the time of issue;

- (e) on the date appointed for the redemption of the stock or any part of it all the interest on the principal moneys represented thereby shall cease to accrue whether payment of the principal shall have been demanded or not;
- (f) interest on stock, and on bonds if interest is payable thereon, shall be payable half yearly or at such longer intervals as the Minister may direct.

6. The Minister may receive, for and on behalf of the Government any grant made to the Government from within Zanzibar, Tanzania Mainland or outside.

Authority to receive grants.

7. In respect of any interest certificate or transfer stock no stamp duty shall be payable.

Exemption from stamp duty.

8. At the time of issue of any bills, bonds or stocks, the Minister may impose conditions pertaining to the following matters:-

Issue of Securities.

- (a) the price of issue of the Security;
- (b) the denominations in which the security will be issued and transferred;
- (c) the rate of interest;
- (d) in the case of bonds, the rates of capital appreciation which may accrue to the principal moneys;
- (e) the times and places of the repayment of principal and payment of interest;
- (f) the exchange of stocks into certificates to bearer and the exchange again, as occasion may require, of such certificates into stock.

Authority to guarantee loans.	9. Where the Minister is satisfied that it is in the public interest to do so, he may guarantee on behalf of the Government in such manner and on such conditions as he may deem fit, the repayment of the principal money and interest or other charges on any loan raised within Zanzibar, Tanzania Mainland or outside Tanzania by a public enterprise or any other corporate body.
Public Enterprise to reimburse Government.	10. Where any guarantee is given in terms of the provisions of section 9 of this Decree, the Public Enterprise for whose benefit such guarantee is given shall reimburse the Government, in such manner as the Minister may direct, all sums of moneys which the Government has paid to fulfill the guarantee and all the expenses which the Government may have incurred in relation to the guarantee and in addition thereto shall pay the Government such interest or service charge in relation to any such sum of money paid or expense incurred by the Government as the Minister may direct. Such moneys received shall be paid into the general revenue of Government.
Amounts due from Government.	11. Any sum of money due from the Government in respect of any foreign or local loan by way of repayment or interest on any bond or stock or guarantee shall be charged on and be paid out of the Government general revenue without further appropriation.
Government to be bound by transaction.	12. It is hereby declared that where a loan whether a foreign loan or a local loan has been raised by the Minister for and on behalf of the Government in terms of the provisions of this Decree, the Government shall be bound by the transaction and section 11 shall apply in relation to the loan notwithstanding compliance or otherwise with the proviso to sections 3 and 4 of this Decree.
Regulations.	13. The Minister may make regulations generally for the better carrying into effect of the purposes stipulated under the provisions of this Decree in regard to the bills, stocks and bonds issued under this Decree.
Repeal of Cap. 140.	14.(1) The General Loan and Stock Decree is hereby repealed. (2) Notwithstanding the repeal of the General Loan and Stock Decree, any loan raised by the Government under the provisions of that Decree in respect of which any liability is subsisting immediately prior to the commencement of this Decree, shall be deemed to be a loan duly raised under this Decree.

THE PUBLIC HEALTH DECREE, (CAP. 73)

The Public Health (Prevention of Disease) Rules, 1978

(Under Section 50)

1. These Rules may be cited as the Public Health (Prevention of Disease) Rules, 1978 and shall come into force on 12th April, 1978.

2. In these Rules:-

“infected area or district” means an area or district infected by Cholera as declared by the Medical Officer of Health in charge of a District.

“effective date” means the 12th April, 1978.

3. In any district or area infected, no person shall be allowed to move into or out of such district or area without a special permit from the Medical Officer of Health in charge of the District.

4. From the effective date, in infected districts or areas, all schools, colleges, cinema centres and all other public places of entertainment shall remain closed until further notice. The holding of public meetings, processions, ngoma or maulidi or wedding ceremonies or burial is prohibited until further notice.

5. All hotels and restaurants shall remain closed to the public and the sale of any kind of food or drink which is consumable by the buyer directly without cooking is also prohibited.

6. No person shall be allowed to visit a patient suffering from Cholera at the hospital and such patients should they die of such an infectious disease shall be buried by employees of the Ministry of Health only.

7.(1) Any person in contravention of these Rules shall, unless he proves to the contrary is guilty of an offence and on conviction is liable to one or more of the following penalties:-

(a) to be committed to an Educational Centre for such a period until the declaration by the Medical Officer of Health is lifted against the outbreak of cholera in Zanzibar;

(b) the food or drink involved may be confiscated by the government for disposal in order to safeguard the lives

of people and no compensation shall be paid for same;

(c) the house used for the sale of food or drink contrary to these Rules together with all the property in it may also be ordered to be forfeited to the government without compensation. It is immaterial as to the owner of such a house;

(d) any vessel or vehicle used for purposes of facilitating the contravention of these Rules may be forfeited to the Government without compensation.

(2) For offences in contravention of these Rules, no bail shall be granted.

- (a) Motor vehicles of all types;

- (c) steamers;
- (d) dhows (mashua);
- (e) radios;
- (f) refrigerators;
- (g) any type of machinery; and
- (h) spare parts for any of the above goods.

4. Any person who contravenes the provisions of this Order shall be guilty of an offence and shall on conviction be liable to serve at an Educational Centre for a period not exceeding two years or to a fine not exceeding shillings ten thousand. In addition, the goods involved may be ordered to be forfeited as Government property.

5. The provisions of this Order shall not apply to diplomats, expatriates, people who come into Zanzibar as employees of the Government or in public service and visitors.

6. The Imports Control (Prohibited Imports) Order, 1977 published as Legal Notice No. 16 of 1977 is hereby revoked.
